(the “**Company**” or “**Newlat Food**”) announces that, following the authorization of the purchase and disposal of own shares by the Shareholders’ Meeting of 29 April 2021, in the period from 2 August to 31 August 2021, the Company bought back a total of 151,654 ordinary shares on the Mercato Telematico Azionario (equal to 0.35% of the share capital) at an average share price of € 6.76 and for a total value of € 1,024,691.89.
