Reggio Emilia, 5 November 2025 – NewPrinces S.p.A. (the “**Company**” or “**NewPrinces**”) announces that, following the authorizations of the purchase and disposal of own shares by the Shareholders’ Meeting of 28 April 2025, in the period from 1 October to 31 October 2025, the Company bought back a total of 163,017 ordinary shares on the Mercato Telematico Azionario (equal to 0.37% of the share capital) at an average share price of € 21.77 and for a total value of € 3,393,227.62.
