(the "Company" or "Newlat Food") announces that, following the authorizations of the purchase and disposal of own shares by the Shareholders' Meeting of 27 April 2023, in the period from 1 September to 30 September 2023, the Company bought back a total of 103,715 ordinary shares on the Mercato Telematico Azionario (equal to 0.24% of the share capital) at an average share price of € 6.14 and for a total value of € 646,088.96.
