SHARE BUY BACK

Reggio Emilia, 5 September 2023 – Newlat Food S.p.A. (the “**Company**” or “**Newlat Food**”) announces that, following the authorizations of the purchase and disposal of own shares by the Shareholders’ Meeting of 27 April 2023, in the period from 1 August to 31 August 2023, the Company (i) bought back a total of 40,991 ordinary shares, on the Mercato Telematico Azionario, at an average share price of € 5.99, for a total value of € 244.254,13, and (ii) sold a total of 200 ordinary shares, on the Mercato Telematico Azionario, at an average share price of € 5.99, for a total value of € 1,198.00.
