(the "Company" or "Newlat Food") announces that, following the authorizations of the purchase and disposal of own shares by the Shareholders' Meeting of 28 April 2022, in the period from 1 March to 31 March 2023, the Company (i) bought back a total of 63,195 ordinary shares, on the Mercato Telematico Azionario, at an average share price of € 4.87, for a total value of € 305,117.23, and (ii) sold a total of 7,400 ordinary shares, on the Mercato Telematico Azionario, at an average share price of € 5.07, for a total value of € 37,532.00.
