Reggio Emilia, 8 September 2021 – Newlat Food S.p.A. (the “Company” or “Newlat Food”), in addition to the press release issued on 6 September 2021, announces that, following the authorization of the purchase and disposal of own shares by the Shareholders’ Meeting of 29 April 2021, in the period from 2 August to 31 August 2021, the Company bought back a total of 225,951 ordinary shares on the Mercato Telematico Azionario (equal to 0.51% of the share capital) at an average share price of € 6.77 and for a total value of € 1,529,641.65.
