CLARIFICATION ABOUT THE ACCIDENT AT WORK
HAPPENED AT THE SANSEPOLCRO PLANT

Reggio Emilia, 19 March 2022 – In reference to what was communicated by various media outlets about an accident at work and the consequent burns of two operators at the Sansepolcro plant in Tuscany, it is specified that – thanks to the timely intervention of the rescue teams and the application of the best practice by the company, which allowed to activate all the necessary tools for the protection of workers – contrary to what was communicated by the media on Friday in the early afternoon, the workers involved in the accident, as far as the company is aware, have not suffered from serious or permanent injuries and one of the two people was discharged from the Bufalini hospital on the same day of the hospitalization, while the second person is under observation.

This clarification is necessary in order to emphasize that the company adopts all the best procedures to protect its workers and that the accident was a result of an unpredictable causality, which will be analyzed and investigated.
