Reggio Emilia, 2 July 2021 – Newlat Food S.p.A. (the “Company” or “Newlat Food”) announces that, following the authorization of the purchase and disposal of own shares by the Shareholders’ Meeting of 29 April 2021, in the period from 1 June to 30 June 2021, the Company bought back a total of 174,500 ordinary shares on the Mercato Telematico Azionario (equal to 0.40% of the share capital) at an average share price of € 6.90 and for a total value of € 1,206,142.06.
