SHARE BUY BACK

Reggio Emilia, 4 December 2024 – Newlat Food S.p.A. (the “**Company**” or “**Newlat Food**”) announces that, following the authorizations of the purchase and disposal of own shares by the Shareholders’ Meeting of 29 April 2024, in the period from 1 November to 30 November 2024, the Company bought back a total of 43,640 ordinary shares on the Mercato Telematico Azionario (equal to 0.10% of the share capital) at an average share price of € 11.54 and for a total value of € 504,914.84.
