SHARE BUY BACK

Reggio Emilia, 7 March 2025 – Newlat Food S.p.A. (the “**Company**” or “**Newlat Food**”) announces that, following the authorizations of the purchase and disposal of own shares by the Shareholders’ Meeting of 29 April 2024, in the period from 1 February to 28 February 2025, the Company bought back a total of 88,914 ordinary shares on the Mercato Telematico Azionario (equal to 0.20% of the share capital) at an average share price of € 12.30 and for a total value of € 1,053,402.28.
