SHARE BUY BACK

Reggio Emilia, 2 October 2025 – NewPrinces S.p.A. (the “**Company**” or “**NewPrinces**”) announces that, following the authorizations of the purchase and disposal of own shares by the Shareholders’ Meeting of 28 April 2025, in the period from 1 September to 30 September 2025, the Company (i) bought back a total of 100,515 ordinary shares, on the Mercato Telematico Azionario, at an average share price of € 23.51, for a total value of € 2,352,746.70, and (ii) sold a total of 18,000 ordinary shares, on the Mercato Telematico Azionario, at an average share price of € 25.84, for a total value of € 464,444.05.
